
We hope you'll consider a legacy gift.

“My Dad passed away three years ago and I was the executor of his estate. It became immediately clear to me how very important it was and is to determine before death where your assets are going to go. If you don’t make a will the state can possibly get everything. Because of the lessons I learned in handling my Dad’s estate I made my own will. I wanted to be sure that my assets went where I wanted them to go.

Some time ago I learned of obstetric fistula and the awful consequences that followed for women who could not get medical care for this condition. I was deeply moved and began donating to the Fistula Foundation in 2004.

This year, in making my own will, I decided to assign a generous portion of my estate to the Fistula Foundation. The idea that by sharing some of my blessings I could help to alleviate some of the terrible suffering in the world appeals to me deeply. I spoke to the staff at the Foundation about my intentions and they helped me through some very simple paperwork and it was done. So easy. You don’t even need a will made. You can just assign a beneficiary (a T.O.D. or “transfer on death.”) for whichever account you choose to donate.

If I can offer any advice it would be to decide now where your assets are going to go now and not later.”
